## **OLD BUSINESS:**

- 1. Remsburg gave the Ecotone update \$121,000 dollars was received for work done to Israel Creek at Buffington Road, the Monthly Report was sent to DNR along with a request for funding of \$74,683 dollars for additional work on Israel Creek. Remsburg sent an invoice to MDE in the amount of \$17,000 dollars for final design to the Broad Run Project.
- 2. Remsburg gave the Manure Injection Equipment update. Denali Water and Tim Mc Michael are interested in the Injector. Richard Strite thinks \$100,000 dollars is a little high-\$85,000 or 90,000 dollars would be more reasonable. Strite asked Remsburg about possibly renting the Injector, no decision was made at this time.
