OLD BUSINESS:

- 1. Remsburg gave the Ecotone update, the Monthly Report was submitted to DNR along with an invoice for the amount of \$65,897 dollars for final payment of the Buffington Road Stream Restoration project. He met with Ecotone and the owner (Alice Stevens) to go over her project Broad Run at Woodsboro. A request was made for \$106,042 dollars to begin the Project, Denny also reported there is going to be a lot of dirt to get rid of and he is going to call Glen Jr. or Rick Eaves to see if the are interested.
- 2. Remsburg gave the Manure Injection Equipment update: Tim McMichael is no longer interested in the Injector, he contacted Stan Fultz and Stan suggested calling some of the Universities. Remsburg reported he has talked to Atlantic Tractor, they would be willing to advertise it. Remsburg is going to put it on the Districts Website and Facebook.
- 3. Remsburg gave the Cover Crop update as of last Friday there was 47 Spring claims submitted to MAC's Office -totaling 8,000 acres and \$290,000 dollars paid out. There have been some partial kill downs reported.
- 4. Hutchinson gave the updated Staff guidelines for Covid-19. Staff can start to go back in the field with prior approval from District Manager and Western Area Coordinator. No face to face contact with Cooperators. Wear mask in Office, only one person in a vehicle and vehicle and equipment wiped down on return.
- 5. Remsburg reported he contacted SHA based on a article in the News-Post announcing Construction to start on the new Park and Ride on Elmer Derr Road this fall, the reply from SHA Real Property Manager said the appraisal has been completed and approved. They are waiting authorization from SHA to formally present the offer to the Districts authorization. Should be approved by the end of the month.

- 4. Remsburg went over the Leadership Assessment tool with the Board. He could not find the by-laws. He will check the Archives at the Thurmont Library and contact other Districts. The latest plan of work found was 2016. A copy was e-mailed to each Board Member and they are to make revisions and mail back to the District Office. The Leadership tool needs to be submitted by June 30TH.

No funds donated to Farm Safety Camp by SCD will be used in the Milk Giveaway Program.
