OLD BUSINESS:

- 1. Remsburg gave the Ecotone update: an invoice has been sent to MDE in the amount of \$54,472 dollars for final payment of the Israel Creek and Broad Run Stream Restoration Projects. Construction to start this fall. MOU and scope of work to be signed and returned to DNR. Total cost of project construction is \$1,149,000 dollars including administration fee to the District.
- 2. Remsburg gave the Manure Injection Equipment update, an invoice has been submitted for May and June Injection in the amount of \$30,826 dollars. Fifty-six acres was covered in July and so far in August. Gary Grossnickle has 100 plus acres to cover once he gets corn chopped. There was some discussion on the sale of the Injector. Remsburg is to contact other Maryland SCD's and the PA SCD Association to see if any of them are interested. Remsburg is going to contact Atlantic Tractor about the sale.
- 3. Remsburg gave the Supervisor Position update. McBride name is going to be submitted by itself, no other persons can be found to serve at this time.
- 4. Remsburg handed out and went over the information discussed at the MASCD Summer Meeting, a few highlights, Major Topics Tort Claims Act, WIP goals, CAFOS and District bylaws. Remsburg is to check on the District bylaws. The District Auction items brought \$140 dollars. Total Auction amount to \$4600 dollars total.
- 5. Remsburg reported the Districts Computers are in and in operation.
